Clerk Report: Michelle Crebo

- Bank account has \$13,300 in currently
- There is \$317,000 left in the Legacy fund at this time.
- We will remind those with offering envelopes the Gold envelope is a special building offering once a month, (the second Sunday of each month), Can be given with tithly if write in memo line Building,
- Motion made to add to the bulletin monthly an income and expense line to keep the congregation up to date on our finances. Made by Jerry D / Roy A.

Building and grounds: Don Crebo

- The No heat in the Sanctuary was due to an actuator that came off to expose all the cold air to come into the building. It is now manually closed till a permanent fix can be made. The company charges double time and a 4 hour minimum for emergency calls.
- Water bill was very high and they are putting a hold on the bill till someone can come out and take a look at it and re read meter. Due for a meter change but unable to be done till March per the water company's calendar.
